Dear Mr Butler,

Thank you for your Freedom of Information request of 14th June 2017. You asked:

How many DLA claimants in receipt of its higher mobility component have so far been awarded the enhanced level of PIP moving around support mobility support; and Of those, what percentage were awarded that support as a result of points from (1) the "moving around" activity, (2) the "planning and following a journey" activity, or (3) a combination of the two.

In addition to the information requested above, could you also inform us if possible –

How many DLA claimants in receipt of its higher mobility component have so far been awarded the standard level of PIP moving around support mobility support; and of those, what percentage were awarded that support as a result of points from (1) the "moving around" activity, (2) the "planning and following a journey" activity, or (3) a combination of the two.

On 19th June you also asked:

How many DLA claimants in receipt of the higher mobility rate of DLA have been assessed for eligibility for their Personal Independence Payment?

A total of 254,200 individuals in receipt of Disability Living Allowance (DLA) higher rate mobility have had a Personal Independence Payment (PIP) reassessment outcome between October 2013 and October 2016.

This information has been published in the table at the following link under the heading "DLA to PIP Reassessment Outcomes" which also provides the number of people moving from each rate of DLA to each rate of PIP.
