Disability Rights UK helpline for students, apprentices and trainees

<u>Disability Rights UK</u> runs a <u>Disabled Students Helpline</u> which offers information and advice to disabled students, apprentices and trainees by phone and email on a range of topics including:

- applying to college, university and apprenticeships
- telling people about your disability
- financial assistance
- adjustments for disabled students and apprentices
- rights in post -16 education and training under the Equality Act 2010
- how to resolve any disagreements.

The helpline supports disabled students, apprentices, parents and carers and professionals supporting disabled students aged over 16 in England.

In addition to the helpline, Disability Rights UK also produces a range of free <u>education factsheets and guides</u> for disabled students, trainees and apprentices on post 16 education and training. Disability Rights UK's <u>Into Apprenticeships 2022</u> <u>guide</u> deals with common questions such as how to find an apprenticeship, whether the training will be accessible and what support is available in the workplace. There are several inspiring stories written by disabled apprentices about their own experiences and the challenges they have faced. The guide also contains a useful resources section listing further websites, publications and organisations which can help.

Advanced Learner Loans

The Adult Learner Loans application service for 2022/23 was launched by the Student Loans Company on Monday 23 May 2022, for learners wishing to take out an Adult Learner Loan (ALL) to fund their learning from 1 August 2022 onwards. Full guidance is attached. Please note the following key changes:

- The expansion of the Level 3 free courses for Jobs offer as of 1 April to include all adults who meet the definition of 'low wage' or 'unemployed' outlined in the <u>AEB funding rules 2022 to 2023</u> who already have a full level 3 or higher achieved prior to 1 April 2021 or who have achieved a short qualification after 1 April 2021.
- As of 2023 any loan remaining 40 years after an individual is due to start making repayments will be written off; previously it was 30 years.

Supporting blind and partially sighted customers: Zoom webinars, July 2022



The Thomas Pocklington Trust is a national charity supporting and empowering blind and partially sighted people to live the life they want to lead. The Education Team works with people aged 11 and above, to access and get the most out of their time in education. They support students with all aspects of their life in education, including access to important services like careers advice, to help them achieve their potential.

In response to the recent survey asking for this kind of training, the Thomas Pocklington Trust will be providing

prime contractors with access to a webinar which will help them become better informed and feel more confident when working with blind and partially sighted customers.

There are two sessions which will run in early July. These will be identical, so there is no need to attend both sessions. After this presentation, there will be the chance for participants to ask questions and to discuss their own examples and experiences of working with blind and partially sighted customers. DWP update: expansion of training flexibility for Universal Credit (UC) claimants



The government has expanded the additional training flexibility for Universal Credit claimants until April 2023.

Universal Credit claimants in the intensive work search group can attend full-time, work-related training opportunities lasting up to 16 weeks as part of their work search activity. This flexibility has been extended until 28 April 2023.

Universal Credit claimants will need to get agreement from their work coach to ensure this is the right support for them and appropriate for the local labour market.

Discover Uni - new features for prospective students and advisers

<u>Discover Uni</u> is the official source of data, information, and guidance about higher education across the UK. It is focused on helping prospective students to make informed choices about higher education.

Discover Uni includes a new comparison feature where users can save courses of interest and compare up to seven, side by side. They can also apply a personal rating system to help them track the courses they are most interested in applying for.

The tool gives access to information and official statistics about the course taken from the **Unistats course data**, collected by the Higher Education Statistics Agency (HESA).

The information and data provide an important reference point for prospective students in their research. Those thinking about going to university can find a range of guidance, including <u>information on what to consider when choosing courses</u>, information about loans and grants, and how to prepare for university once they have applied and secured a place.

Discover Uni also provides <u>information for teachers and advisers</u> and a downloadable resource.

New report from UCAS:



Next steps: What is the experience of disabled students in education?

The report has been written in partnership with Pearson and the Disabled Students' Commission. It explores how disabled students who have applied to university or college this year feel about the support they have received so far, and what they're looking forward to in higher education. Key findings include:

- In 2021, over 83,000 students shared a disability in their UCAS application this
 has more than doubled over the past ten years showing that students are feeling
 increasingly comfortable sharing this information. However, disabled people are
 still under-represented in higher education.
- Only 17% say they have access to inclusive extra-curricular activities at school or college. However, there is excitement about progressing to higher education, with 44% expecting the social aspect of life at university or college to be 'good' or 'excellent'.
- UCAS' analysis of data from last year's admissions cycle shows students with disabilities are 28% more likely to defer, and this increased during the pandemic. The deferral rate for disabled applicants rose from the pre-pandemic 7% in 2019 to 8.2% in 2021 (compared to a 6.4% deferral rate for non-disabled applicants in 2021). The steepest increase was seen for those with social, behavioural or communication impairments (e.g. an autistic spectrum condition.
- Early engagement is key for these students 56% researched available support before applying, with students commonly looking at the general and educational support available, and facilities and physical adjustments on campus prior to making their application decisions.

For the first time, our research breaks down the application and survey data of disabled applicants by impairment category to understand the key variations and differences by impairment type, and we also look at the intersectionality of other personal characteristics to understand where there are additional barriers and considerations. UCAS is calling for the journey of disabled students into higher education and apprenticeships to be made easier - and start earlier - through the extension of the DWP's Access to Work Adjustment Passports, which currently cover the transition from HE into employment, plus earlier engagement with university and student support, including Disabled Students' Allowances.
