Disabled Apprentice Network 2023 report launch!



The Disabled Apprentice Network (DAN) will launch its 2023 report *Speaking from experience: Getting It right for Disabled apprentices* on February 8th during National Apprenticeship Week.

It is Disability Rights UK's follow-up report to 2022's **Getting it Right for Disabled Apprentices.**

The report considers what works well through collecting and analysing young Disabled people's experiences of how they receive information about apprenticeships; their engagement with training providers and employers, and the support they have received. We also collected the views from various stakeholders who work with Disabled young people.

The <u>Disabled Apprentice Network</u> (DAN) is a forum for Disabled apprentices, where they can share their experiences and offer ideas and proposals on how to improve apprenticeships for Disabled people.

Organisations are encouraged to work to the Principles of Good Youth Employment and can sign up free of

charge to the Youth Friendly Employer Badge & be listed on the Youth Friendly Employer Database to be recognised for their commitment to the 5 principles.

When you sign up to the <u>Good Youth Employment Charter</u>, you will be given access to further support and guidance and access the partner Toolkit. You will also be able to download the Youth Friendly Employer Badge and update your listing on the Youth Friendly Employer Database.

Noel

I am currently working at Electric Pavilion, which is a local restaurant, in Northampton, on a supported internship.

My day-to-day tasks at work vary on what tasks get set by my mentor on the day, but include tasks like, food preparation general cleaning, and putting away deliveries.

My favourite things to prepare are salad foods, I especially enjoy using the salad spinner after I have washed the baby gem lettuce.

I have been working at Electric pavilion for 3 months.

In the beginning it was interesting to understand how the world of work works, as I

have never had a full-time job and the change to routine was hard to adapt to but, I quickly adjusted to the longer hours and being on my feet all day and enjoy going to work. I look forward to seeing what my tasks will be for the day.

My supported internship means I get regular visits from my job coach, and she works closely with my mentor at work to make sure I am happy in my environment.

We all work together to set myself termly targets to work on while on the job and this term is Knife skills, I feel like it's going well but still needs work, there are plenty of opportunities to practice because something always needs chopping. I am getting more and more confident with the bigger knifes and hope to be able to chop foods as fast and neatly as my mentor one day.

Since working at electric pavilion, I have had to try new foods that I wouldn't have done before, for example a blackberry compote, and a pulled pork burger, which tasted amazing. My mentor encourages me to try all the food we prepare, so I know how it should taste every time.

I am enjoying my work placement and hope to continue my career in catering after my supported internship finalises in July.



Tom



Tom did an information support technician level 3 apprenticeship. He initially looked into going to college, but then decided that an apprenticeship was a better route.

His school, Undershaw (formerly Stepping Stones) did individualised support with Tom and explored which training provider would work best for him to offer the additional support with maths and English. Because of his health condition, Tom needed a reasonable adjustment and had his weekly work and study timetable reduced.

Tom says that his employer was very helpful and that "The apprenticeship was a learning curve. I liked the fact that I could make a mistake and not be told off about it."

Helpline for students, apprentices and trainees

<u>Disability Rights UK</u> runs a <u>Disabled Students Helpline</u> which offers information and advice to disabled students, apprentices and trainees by phone and email on a range of topics including:

- applying to college, university and apprenticeships

- adjustments for disabled students and apprentices
- rights in post -16 education and training under the Equality Act 2010
